Cinco de Mayo Car, Truck and Bike Show General Rules & Regulations:

1. **REGISTRATION:** All vehicles must arrive by 11:30 a.m. and check in before 11:30 a.m. on Saturday May 4th, 2019. Check in will start at 9:30 a.m. at Plato and Cesar Chavez Street. Security will be available for placement assistance.
2. **JUDGING CARD:** Each entrant will be given a registration/judging card upon entry. The registration/Judging card must be placed on the dashboard and visible to the judges. It is the entrant's responsibility to ensure that the registration card is visible and properly completed by starting time. Vehicles not displaying the judging/registration car will not be judged.
3. **COMMON COURTESY:** Be polite and considerate to all guests - remember that you are representing the Cinco de Mayo Fiesta Car Show and the car club you are affiliated with. Profanity and other disrespectful conduct including displays which incorporate objectionable music, videos, artwork or other items is prohibited.
4. **EXCESSIVE NOISE:** Loud music should be kept to a minimum.
5. **SAFETY CONCERNS:** Children under 12 years of age and MUST be adequately supervised/accompanied by an adult during all periods of the car show. Also, for safety of participants NO pets, bikes, skateboards and rollerblades are allowed on the festival grounds.
6. **ALL EXHIBITION AND SAFETY RULES APPLY/DISQUALIFICATION:** All entrants must adhere to the "Exhibition and Safety Rules" of the Show, which are incorporated by reference herein. Failure to comply with any Exhibition and Safety Rule may be grounds for disqualification, at the sole and participate may be asked to leave the premises.
