Thank you for your contribution to the West Side Community Village. You are an important part of this community. Below you will find all the information about becoming a vendor at Cinco de Mayo - West Side - Saint Paul, [Saturday, May 4, 2019 from 9 am until 4 pm.](#)

**Application Information:**

To become an official vendor, please complete and return the West Side Community Village application with full payment by **Monday, April 8, 2019.**

A flat reduced application rate of \$50 is offered only to West Side community residents, workers, and volunteers of the 55107 zip code. This discounted opportunity is available to our community members to ensure that our neighborhood and local economy are able to affordably participate and benefit from our own long-standing community and cultural tradition. In this way, it is our goal to support and showcase local West Side artists, crafters, growers, vendors, and community initiatives.

We aim to keep fees as low as possible so that you can also keep your prices low. Because of this we offer exclusively in the Community Village area a bring-your-own option where tables, tents, and chairs will not be required. A blanket on the ground will be accepted in your 10'x10' vending area. Permits and insurance will also not be required but please ask questions if you are unsure.

Abiding by these suggestions will not only assist you in making the event as profitable as possible, but will ensure your participation in future celebrations:

**Set-up Time:** [Saturday 6 am to 8 am.](#)

**Festival Hours:** [Saturday 9 am to 4 pm.](#)

**Tear Down/Check out:** [Saturday 4 pm.](#)

This is YOUR neighborhood. We will all clean our areas in the park together leaving it garbage free for the children who play there. Failure to clean your booth area may forfeit your chance to participate in future opportunities for Cinco de Mayo – West Side – Saint Paul. Please, be sure to check-out with the West Side Community Village coordinator, before leaving the park.

**All vendors are responsible to provide the following:**

- Bring-your-own blankets, rugs, boxes, tables, chairs, electricity, tent or anything else you need to set-up your booth. SPFH will supply table, chairs, 10'x10' tent, or generator for rental fees upon request.
- Growers/Farmers must provide a washing bucket, water, anti-bacterial soap, and roll of disposable towels per Saint Paul Farmer's Market regulations. No prepared food vendors for this year.

**Exclusivity for Approved Vendors:**

Cinco de Mayo – West Side – Saint Paul protects the interests of its authorized vendors by allowing only Cinco de Mayo – West Side – Saint Paul approved vendors to participate. With a block permit issued by the City of Saint Paul, Cinco de Mayo – West Side - Saint Paul controls all outside vending within 2000 feet every direction of the outer perimeters of the event. City Licensing staff, the Saint Paul Police Department and our Staff/Committee will be checking every vendor for the Official Cinco de Mayo – West Side - Saint Paul designation as well as all City of Saint Paul Permits required by law.
